#### **The Naughton Dunn Club**

Naughton Dunn was born in Aberdeen in 1884 and was educated in the grammar school and university of that city, graduating in medicine in 1909.

His interest in orthopaedic surgery began with his appointment as house surgeon to the late Sir Robert Jones at the Royal Southern Hospital, some years before the Great War.



At the end of 1917 Sir Robert Jones transferred Major Dunn to Birmingham as surgeon in charge of all military orthopaedic hospitals in the area.

Following his training in orthopaedic surgery, he transferred to Birmingham, where he became associated with the Birmingham Cripples Union.

He was connected with many hospitals in the Midlands, both in an active and in an advisory capacity, and he held a very important post of lecturer in Orthopaedic Surgery at the University of Birmingham.

He played major part in amalgamating both the Birmingham Cripples' Union and the Woodlands with the Royal Orthopaedic and Spinal Hospital to become the first Royal Cripples' Hospital and now the Royal Orthopaedic Hospital.

Wider recognition of the value and originality of his work came to him through his efforts during and after the Great War. He was a founding member of the British Orthopaedic Association of which he was president in 1938/3

# Consultant Hand and Peripheral Nerve Surgeon MA MB BChir (Cantab) FRCS (Trauma and Orth)

Brachial Plexus and Peripheral Nerve Injury Service Queen Elizabeth Hospital, Birmingham.



Dominic Power is a Consultant Hand and Peripheral Nerve Surgeon at the Birmingham Hand Centre treating civilians and the Royal Centre for Defence Medicine treating combat injured UK and coalition personnel. He is the co-founder of the West Midlands Brachial Plexus and Peripheral Nerve Injury Service. His clinical work is predominantly focused on the management of nerve injury, paralysis and nerve pain.

In 2014 he co-founded the HaPPeN research group to develop high quality clinical trials in Hand Surgery, Plastic Surgery and Peripheral Nerve Surgery. His research interests include scar free healing in peripheral nerve repair, optimising neural regeneration and exploring the potential for axon fusion repair after transection nerve injury. He has more than 100 peer reviewed publications and during the last 5 years him and his team have delivered more than 150 research podium and poster presentations at national and international academic meetings and conferences.

Dominic Power is a co-founder and member of the board of directors for the Global Nerve Foundation, a non-profit with a focus on education, research, advocacy and awareness in the field of peripheral nerve. He is an Honorary Senior Clinical Lecturer in the School of Inflammation and Ageing at the Birmingham University Medical School and a Senior Academic Clinical Fellow at the Aston University Medical School. He is regularly invited to lecture on advanced peripheral nerve surgery reconstruction with more than 200 lectures delivered in the last 5 years. He delivers practical technique training with UK and International basic, advanced and nerve transfer surgery cadaveric workshops.
